LAW N°888 AMENDMENT OF LAW N°. 606 "ORGANIC LAW OF THE LEGISLATURE OF THE REPUBLIC OF NICARAGUA. "The legislature of the Republic of Nicaragua is exercised by the National Assembly delegation and mandate of the people, is governed by the Constitution and laws. The Organic Act of the legislature seeks to regulate the organization, functions, powers and procedures of the National Assembly". Gazette N° 21, Pages 1086 of 02/2/2015.

DECREE N° 05-2015 AMENDMENT TO DECREE N°. 71-98 REGULATION OF LAW N ° 290 AND ITS REFORMS "LAW OF ORGANIZATION, COMPETENCE AND PROCEDURES OF THE EXECUTIVE POWER". "In terms of the structure of the Presidency of the Republic, paragraph 1.21 is added to Article 4 of Decree No. 71-98, as amended "Rules of Law No. 290 Law on Organization and Procedures of the Executive Branch shall read as : Article 4. Structure. For proper operation, the Presidency of the Republic is divided into: 1. Advisors to the President of the Republic: 1.21. LAW N° 895 AMENDMENT OF LAW N°. 663 "CORPORATIONS LAW SYSTEM OF MUTUAL WARRANTIES FOR MICRO, SMALL AND MEDIUM ENTERPRISES. " Regulates the establishment, operation and functioning of the System of Mutual Guarantee Societies to provide micro, small and medium enterprises (MSMEs), access to finance, procurement and public and private acquisitions through guarantees, bonds and other guarantees, called for purposes of this Act as "financial guarantees or pay" as well as provide training and technical, economic and financial advice." LAW N° 896 "LAW AGAINST HUMAN TRAFFICKING". "Aims prevention, investigation, prosecution and punishment of the crime of trafficking and the protection and comprehensive care of people and especially victims and witness protection, technicians, experts, expert witnesses and other persons involved in the investigation and criminal process, including national transfers to other parts of national or international territory and foreigners without distinction of their immigration status to be transferred to the national territory".
