NATIONAL ASSEMBLY

LAW N° 901 AMENDMENT LAW N° 532, “LAW FOR THE PROMOTION OF GENERATION OF ELECTRICITY FROM RENEWABLE SOURCES”. “The period to qualify for the tax benefits in this area is about to expire; therefore, the government decided to extend it in order to continue promoting renewable energy investments in our country”. DECREE N° A. N. N°.7783 “DECREE APPROVING THE ACCESSION TO THE AMENDMENT TO THE MARRAKESH AGREEMENT WHICH ESTABLISHES THE WORLD TRADE ORGANIZATION (WTO), ELABORATED IN GENEVA ON NOVEMBER 27, 2014 AND ITS ATTACHMENT AGREEMENT, THE AGREEMENT ON TRADE FACILITATION”. “This approval will give legal effects in and out of Nicaragua concerning trade facilitation”. Dated May 19, 2015. “STANDARD FOR PRE- PRINTED SIGNATURES ON FINANCIAL CONTRACTS”. “This standard aims to allow banks, financial companies/agencies and insurance companies to use pre-printed signature of the legal representative of the institution or previously authorized person for that purpose, in contracts regarding this standard in order to expedite the service to its customers”.
